## Terms and Conditions

**\* LIABILITIES:**

***Airlines:***

Incase of loss of one or more packages, airlines compensate the loss as per the Commercial invoice value or US\$ 20 per kg, whichever is less.

***Liner:***

House Stuff (loading): Stuffing (loading) taking place in shipper's warehouse or outside the port premises or dock.

- Liner will not be responsible for the theft, loss, damage or pilferage of the goods hence, he is not liable for such incidence.

Dock Stuff (loading): Stuffing (loading) taking place within the port premises or dock and in the presence of surveyor.

- Liner accepts responsibility for any mishap but subject to certain conditions; intactness of seal when taking delivery, survey at destination etc.

***Courier:***

It is strictly limited to US\$ 100 per shipment.

***New York Cargo:***

As a freight forwarder our liability is limited as per the rule and regulation defined in Standard Trading Conditions of Nepal Freight Forwarder's Association (NEFFA)

***We cannot take liability for:***

1. Confiscation or seizure by customs of antiques or any other items, which is illegal for export.
2. Delayed shipments
3. Damage occurring during the period of such carriage by air, road or other mode of transport

**\* INSURANCE**

It is always good idea to buy insurance for sea and courier shipment, which cost 1% of the total insured value.

Documents specified hereunder are required for the valid admissible of insurance claim;

1. Intimation Letter from Consignee
2. Surveyor report in case of surveyor deputation
3. Photographs of the damaged/broken items
4. Claim form duly completed & signed by consignee

**SHIPMENT BILLINGS:**

***Airlines:***

Please be aware that Airlines follow the IATA rules with regards to the gross or volumetric weight and charges on the basis whichever is higher for e.g. dimensional weight in kilos = length X breath X height in centimeter . If you have any doubt about this please consult with our personnel.

***Courier:*** Same as airlines.

***Liner:*** The liners charge on the basis of volumetric weight

**GENERAL:**

- If New York Traders & Exporters is a shipper, foreign currency has to be deposited into our account that should be equivalent to goods you are

going to buy. You will get Nepali Rupees in return or we can pay suppliers on your behalf. We accept TC, Credit cards, Swift transfer etc.

- Correct Supplier Bills must be supplied in order to make documentations for customs clearance as well as for insurance claim in case of loss of goods.
- Reception or Warehouse personnel must be informed for fragile or valuable items.
- 24 hours notice is required if a vehicle is required for pick up.
- Dangerous, highly inflammable or illegal goods are not accepted.
